

## Average daily results for the last seven days

**Note for reading these tables:** These results show the average of all hourly results reported during a 24-hour period. Each result therefore represents an average over the full day. The results track our performance towards meeting our Environmental Authority (EA) limit of an average daily rate of 230 micrograms per cubic metre of air ( $\mu g/m^3$ ).
